

**Press Release 7.11.16**

Local social enterprise, Fal Energy Partnership (FEP) has been awarded nearly £20,000 from the Rural Community Energy Fund (RCEF) to do a feasibility study into generating 2MW of solar-powered electricity from business, farm and public sector roofs in the Falmouth and Penryn area.

Cornwall is fortunate that it receives a lot of sunshine, particularly during the summer months when there are many additional residents and visitors. This makes our area especially suited to solar power which could provide cheaper electricity to the roof owners and generate an income for the community. If the installations go ahead, it is hoped that FEP will be able to employ a dedicated Energy Manager who will work on issues around fuel poverty, energy saving and renewable energies.

“We are very pleased to be able to do this study” said Charmian Larke, Chair of FEP. “There are many very large roofs in Falmouth and Penryn that would be suitable and it would be great to benefit not only the farms, businesses and organisations by selling them cheaper electricity but ultimately our whole community by helping alleviate fuel poverty and by providing greater energy security.

FEP produced a major report in 2012 showing the large potential local economic benefits to be gained from using local renewable energy sources and reducing energy needs at home and work. This report also showed the unexpectedly high incidence of fuel poverty in parts of the area, where fuel costs are over 10% of household incomes.
